

Fence Outing: Personal Assumption of Risk - Wavier of Liability - Release of All Claims

In consideration of my acceptance as a participant in this and future Fence Outings (Outing), I agree and acknowledge that I may be exposed to a variety of risks, foreseen or unforeseen, which may occur in such Outings. Outings may include fence work, trash pickup, hiking, and other activities. The risks I am assuming include, but are not limited to, personal injury, property damage, illness and death. I acknowledge and accept the hazards and risks of the Outings and I do not minimize my understanding of these risks and that injuries can occur either as a result of accident, negligence or any other reason. I acknowledge that risks of injury, illness or death are involved in outdoor activities such as in these Outings and I agree that I may have to exercise extra care for my own safety and for the safety of others. I further understand that on these Outings there may well **not** be rescue or medical facilities or expertise necessary to deal with injuries to which I may be exposed.

I agree that I have read or listened to any rules and conditions applicable to these Outings. I acknowledge my participation is at the discretion of the organizers or a designated Outing leader. I understand the Outings begin and end at the location(s) designated by the organizers and includes any transportation provided by others associated with the Outings.

- If I decide to leave early and not to complete an Outing as planned, I assume any and all additional risks inherent in my decision. Likewise, if the leader has concluded any Outing, and I decide to go forward without the leader, I assume any and all risks inherent in my decision. In either event, I agree to waive any and all claims and release from liability the organizers, their officers, directors, employees, members, volunteers, agents, and leaders from my decision.
- I agree that this Wavier and Release is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Wavier and Release is held to be invalid or legally unenforceable for any reason, the remainder of this Wavier and Release shall not be affected thereby and shall remain valid and fully enforceable.
- I agree to **WAIVE AND DISCHARGE ANY AND ALL CLAIMS, AND RELEASE FROM ANY AND ALL LIABILITY** the organizers, their officers, directors, employees, members, volunteers, agents, and leaders on account of, or in any way resulting in Injuries and damages, even if caused by negligence on the part of the organizers, their officers, directors, employees, members, volunteers, agents, and leaders, in any way connected with these Outings. I further agree to **HOLD HARMLESS** the organizers, their officers, directors, employees, members, volunteers, agents, and leaders from any claims, damages, injuries or losses caused by my own actions or negligence while a participant on an Outing. I understand and agree that this assumption of risk, and the wavier and release shall be binding upon my heirs, executors, administrators and assigns, and includes and applies to any minors* accompanying me on any and all Outings.
